## **Ordinance 2024-11**

## AN ORDINANCE OF THE CITY OF WOODLAND HILLS CITY COUNCIL AMENDING CITY CODE 6.1.3A

Be it ordained by the City Council of Woodland Hills City; Woodland Hills Municipal Code Title 6.1.3A - Parking, Towing, and Impoundment of Vehicles be amended to read as follows:

- A. The following vehicles, together with or in addition to any other vehicles, parked in violation of any provision of this chapter or the laws of the state, are declared to be nuisances:
  - 1. Any **attended or** unattended vehicle stopped, standing or parked in violation of any of the provisions of this code;
  - 2. A vehicle found upon the streets or alleys of the city with faulty or defective equipment;
  - 3. Any vehicle upon a street so disabled as to constitute an obstruction of traffic and the person in charge of the vehicle is by reason of physical injury incapacitated to such an extent as to be unable to provide for its custody or removal;
  - 4. Any vehicle left attended or unattended upon a street or alley or so parked illegally as to constitute a hazard or obstruction to the normal movement of traffic or in violation of a posted "No Parking" zone.
  - 5. Any vehicle left parked in the same place on any street or alley or upon any public property continuously for twelve (12) hours or between the hours of one o'clock (1:00) a.m. and five o'clock (5:00) a.m.;
  - 6. Any vehicle, the driver of which has been taken into custody by the police or sheriff's department under such circumstances as would leave the vehicle unattended in a street, alley or restricted parking area;
  - 7. Any vehicle found being driven on the streets not in proper condition to be driven;
  - 8. Any vehicle found so parked as to constitute a fire hazard or an obstruction to firefighting apparatus.
