ORDINANCE NO. 2023-15

AN ORDINANCE AMENDING CITY CODE 1.3.2 ADDING A DEFINITION FOR BUSINESS DAYS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WOODLAND HILLS, UTAH, City Code Title 1.3.2 be amended to include:

Whenever the following words or terms are used in this code, they shall have such meanings herein ascribed to them, unless the context makes such meaning repugnant thereto:

BUSINESS DAYS: Means Mondays thru Thursdays, and does not include Fridays, Saturday, Sundays, or legal holidays as outlined in Utah Code Section 63G-1-301, plus Christmas Eve.

CITY: The city of Woodland Hills, Utah.

CITY COUNCIL: The city council of the city of Woodland Hills, Utah.

CODE: The city code of the city of Woodland Hills, Utah.

COUNTY: The county of Utah, state of Utah.

FEE: A sum of money charged by the city for the carrying on of a business, profession or occupation or other activity subject to city regulation, authorization or limitation.

PERSON: Any public or private corporation, firm, partnership, association, organization, government or any other group acting as a unit, as well as a natural person.

STATE: The state of Utah.

WRITTEN, IN WRITING: May include printing and any other mode of representing words and letters, but when the written signature of any person is required by law to any official or public writing or bond, it shall be in the proper handwriting of such person, or in case such person is unable to write, by such person's proper mark.
